RESOLUTION NO. 20-702**

**A RESOLUTION ADOPTING THE 2020-2021 BUDGET OF THE CITY OF DAMASCUS,  
MAKING APPROPRIATIONS, IMPOSING THE TAX AND CATEGORIZING THE TAX**

**WHEREAS**, the City of Damascus Budget Committee approved the 2020-2021 budget on June 12, 2020; and

**WHEREAS**, the notice of this budget hearing (Form LB-1) was published in the June 19, 2020 *Gresham Outlook*; and was presented on the City website ([www.damascusoregon.city](http://www.damascusoregon.city))

**NOW, THEREFORE, BE IT RESOLVED:**

Section 1. Adopting the Budget. The City Council of the City of Damascus hereby adopts the budget for July 1, 2020-June 30, 2021, in the total of \$2,398,000 now on the City website ([www.damascusoregon.city](http://www.damascusoregon.city)). It is also available from the Mayor or from the City Attorney.

Section 2. Making Appropriations. The amounts for the 2020-2021 fiscal year budget beginning July 1, 2020 and for the purposes below are hereby appropriated:
